The Library Foundation enhances our library's leadership, innovation and reach, helping Multnomah County Library address emerging community needs, and sustain a strong library system. Gifts, large and small, from individuals, foundations and businesses make this work possible.

School-age literacy programs reach into all 8 school districts and out into the community, engaging more than 140,000 children and teens in activities that cement reading skills and academic success. Three primary investments last year: Books 2 U brought inspiring "booktalkers" and take-home books to over 20,000 students attending low performing public schools. Summer Reading reached more than 110,000 babies, children and teens, including 98% of elementary school students in the county. In one of our highest risk neighborhoods, the new Rockwood Library Makerspace brought a safe, hands-on, technology-rich learning environment, and programming to 600 teens. Welcome to Reading kits, at 13 libraries, reached 19,700 children and parents.

4b (Code:) (Expenses \$ 448,446. including grants of \$ 278,539.) (Revenue \$)

Early literacy programs reached 77,000 babies, young children and parents, especially those at greatest risk for low literacy. Targeting families with limited resources and reading ability during a crucial window for early brain development, these programs help parents become the first, best, and most permanent teachers of their children. The New Parent Program reached 6,200 new parents and babies in hospitals, encouraging parents to read to their newborns at home and visit the library. Every Child A Reader reached 34,000 young children and parents, sending books home weekly, educating parents and motivating families to read together at home. The WIC partnership educated 7,700 moms about early brain development. Dia de los Ninos reached 12,700 children, parents and caregivers with bilingual literacy programs.

An array of lifelong learning programs, workshops and events at library branches and outreach centers reach people of all ages. Everybody Reads and the Teen Author Program reached 3,500 students by bringing books, reading curriculum and discussion groups to 30 middle and high schools and youth organizations, transforming how students experience reading, writing, and the significance of the written word. Children and adults accessed free arts, cultural, and humanities programs at branches across the system. Seniors and adults participated in the Everybody Reads community-wide reading program, including lectures and book discussion groups. Last year, more than 15,000 people were reached with these programs.

board chair, will review and discuss, either in person, via telephone, or via email, the draft in advance of filing.

Form 990, Part VI, Section B, Line 12c:
